Assume we purchase \$50,000 in bonds of ABC Corporation for \$45,000 cash. The bonds have a stated interest rate of 10% paid semi-annually and the bond matures in 5 years. To record the purchase of these bonds, we record the amount we actually paid for the bonds (we do not use discount or premium accounts):

Accounting for Investment in Bonds | Financial Accounting

Debentures/bonds are a type of financial asset issued by a company giving the holders the right to receive regular interest payments on a fixed date along with the principal repayment on maturity. Unlike, dividend on equity share, interest payments on debenture is compulsory even if the company makes a loss. During liquidation, these instrument holders get preference over equity and preference shareholders.

Financial Asset at Fair Value through Profit or Loss: These include financial assets that an entity holds for trading purposes or are recognized at fair value through profit or loss. Held to Maturity Securities: Investments in debt instruments held till maturity date irrespective of changes in market prices or the entity's financial position or performance falls under this category.
