Under section 203 of the Immigration and Nationality Act (INA), U.S. citizens can act as green card sponsors for their immediate relatives. The INA defines an "immediate relative" as a U.S. citizen's spouse, unmarried child who is less than 21 years old, or parent (if the U.S. citizen is more than 21 years old).
